



Make sure the gang box is installed on the wall.





3 Align the device with the mounting plate, and secure the device on the mounting plate with 1 supplied screw (SC-CM4X14-5T10-SUSS).





4 Quick Operation

Activation via Device

After powering on, you will enter the activation page.

Enter password and press "OK" to confirm password.



- Press" to shift input method.
- Characters containing admin and nimda are not supported to be set as activation password.

5 Add Face Picture

- 1. Hold OK and login the device to enter the home page.
- 2. Select User -> Add User to enter the Add User page.
- 3. Set the user parameters according to actual needs. (i) Only the device with the fingerprint module support the fingerprint related functions.
- 4. Select Face and add the face information according to the instructions.

You can view the captured picture on the screen. Make sure the face picture is in good quality and size.

- 5. Press OK to save the face picture. Or press ESC to select Retake and adjust your face position to add the face picture again.
- 6. Press ESC and then press OK to save the settings. Go back to the initial page to start authentication. For other authentication methods, see the device user

Expression

- Keep your expression naturally when collecting or comparing face pictures, just like the expression in the picture on the right.
- Do not wear hat, sunglasses, or other accessories that can affect the facial recognition function.
- Do not make your hair cover your eyes, ears, etc. and heavy makeup is not allowed

Posture

In order to get a good quality and accurate face picture, position your face looking at the camera when collecting or comparing face picture.



Size


