### Type I

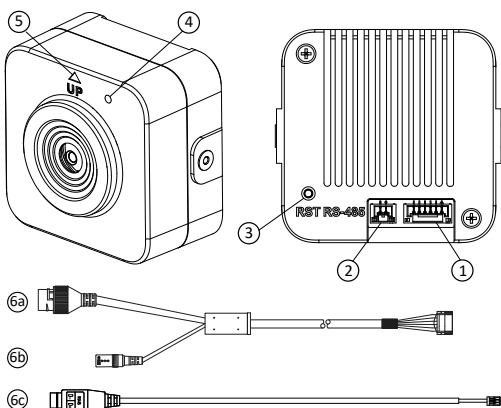


Figure 1-1 Overview (Type I)

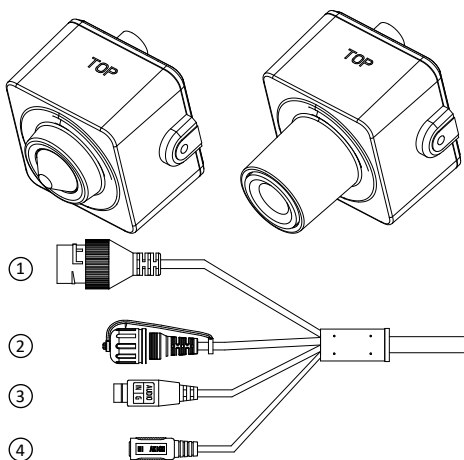


Figure 1-2 Overview (Type II/III)

## 2 Installation

### Before you start

- Make sure that the device in the package is in good condition and all the assembly parts are included.
- Make sure that all the related equipment is power-off during the installation.
- Check the specification of the products for the installation environment.
- Check whether the power supply is matched with your power output to avoid damage.
- Make sure the wall is strong enough to withstand four times the weight of the camera and the mount.
- Do not cover the microphone to avoid poor reception.
- Waterproof the network cables and insulate and waterproof the other device cables to prevent water from entering the cables and affecting their use.
- The installation steps of all devices in this manual are similar and here takes type I as an example to describe the steps.

### 2.1 Ceiling Mounting

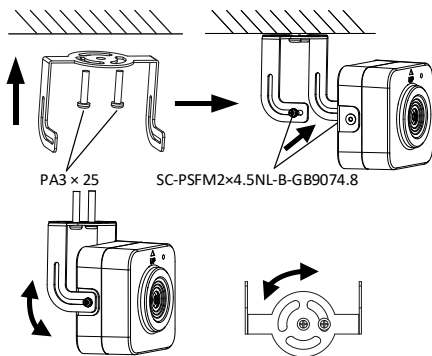


Figure 2-1 Ceiling Mounting

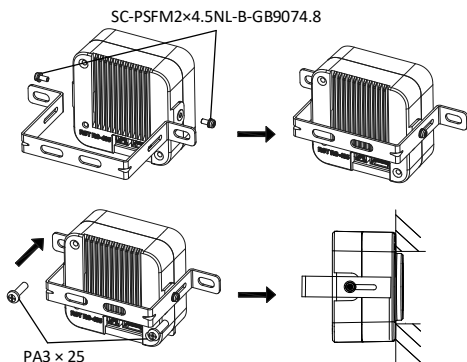


Figure 2-2 Wall Mounting
